UK

- The Combined Space Operations Initiative (CSpO) partners exchanged views on space threats, conducted a tabletop exercise, and endorsed a joint statement. The group is formed of Australia, Canada, France, Germany, Italy, Japan, New Zealand, Norway, the United Kingdom and the United States.
- The City of London Police decided not to take action against anyone over a complaint made by the Pakistan High Commission in London alleging an attack on Justice (retired) Qazi Faez Isa and the High Commission's diplomatic car outside the Middle Temple by Pakistan Tehreek-e-Insaf (PTI) activists on October 28 2024.
- The Government announced a full asset freeze against Brian Sheridan, which they have reasonable cause to suspect is involved in terrorist activity by facilitating terrorism and associating with members of the New Irish Republican Army ('New IRA').
- The Government also announced three further sanctions on individuals connected to ISIS and Al-Qaeda.
- John Healey, the Defence Secretary, delivered a speech at the London Defence Conference. His department published a Statement of Intent regarding the Defence Industrial Strategy.

Opposition blocs on the left and far-right have united to block the budget, ensuring it cannot pass without substantial abstentions, which appear unlikely. The crisis has shaken market confidence, reflected in volatile bond markets. Without swift, decisive measures, France risks further financial instability and loss of investor trust.

- Comment: Syria becomes a focal point in global geopolitics, with escalating tensions as a rebel coalition, led by Hayat Tahrir al-Sham, challenges Bashar al-Assad's regime. This conflict has drawn in powers like Iran, Russia, the US, China, and Turkey, often through proxies. Syria's role as a narco-state, producing 80% of the world's Captagon drug, exacerbates regional instability, especially affecting Saudi Arabia and Jordan. The UK and US have imposed sanctions on key individuals linked to the Captagon trade, recognising its geopolitical and security implications. Several companies and organisations are alleged to have profited from the chaos, including Russia's Wagner Group, and French cement group Lafarge. With Syria's ongoing economic collapse, Britain continues to collaborate with allies to monitor developments, leveraging international support through forums and potential sanctions. As the region's complexities deepen, Syria remains a critical issue for British foreign policy.

Bahrain

 Alistair Long, Ambassador to Bahrain, met Yasser bin Ibrahim Humaidan, Minister of Electricity and Water Affairs. They discussed "fostering constructive collaboration with Bahrain for the benefit of both nations and their people."

Qatar

- Qatar's Emir Sheikh Tamim bin Hamad Al-Thani visited the UK for a state visit, highlighting key economic, geopolitical, and defence partnerships. The UK aims to boost ties with Gulf Cooperation Council (GCC) countries for investment, especially after a 75% drop in UK imports from Qatar. Despite this, Qatar remains a major UK investor, with a £40 billion portfolio and a new £1 billion pledge for climate technologies. Rolls-Royce notably benefited from these commitments.
- Key agreements included doubling joint aid funding to £79 million for global challenges, enhanced defence cooperation (including Typhoon and Hawk jets), and cybersecurity initiatives. The UK and Qatar also expanded collaboration in AI and genomics, including the launch of an AI research commission and the establishment of a shared Genomics Medicine Academy to improve healthcare and drive economic growth. Additionally, both countries agreed to coordinate on regional geopolitical concerns such as Palestine, Sudan, and Yemen.







Africa

Libya

• Martin Longden, Ambassador to Libya, met Prime Minister of the Government of National Unity, Abdul Hamid Dbeibah. Local media reported both sides discussed the return of British oil companies to work in the country.

Tanzania

- Marianne Young, High Commissioner to Tanzania, met President Hussein Ali Mwinyi and Minister of Tourism and Heritage, Mudrick Soraga. British travellers make up the 4th largest group of visitors to Zanzibar, with over 34,000 British tourists visiting the islands this year.
- The British Geological Survey team arrived in Tanzania, where they partnered with the Geological Survey of Tanzania "to provide technical assistance on critical minerals."

Somalia

• Mike Nithavrianakis, Ambassador to Somalia, and Brigadier Oliver Bryant met Somali Chief of Defence Forces General Raage to discuss security and defend matters.

Cameroon

• Lord Collins, the Minister for Africa, attended the UK-Francophone West and Central Africa Trade and Investment Forum in London. Britain closed a finance deal worth over £60 million to help Cameroon improve vast swathes of land for agriculture, supported by British firms.

Bangladesh

She met the Minister of Finance "to discuss progress on Pakistan's IMF-supported programme, and ongoing UK technical assistance to support the Government of Pakistan's economic reform priorities."
- Comment: Bangladesh has experienced significant political turmoil, with Prime Minister Sheikh Hasina's resignation and Nobel laureate Muhammad Yunus leading an interim administration. The UK has closely monitored developments, including a parliamentary report detailing over 2,000 "atrocities" since the regime change, and concerns over the rising influence of Islamists. Additionally, Bangladesh has raised concerns about laundered money in the UK, requesting its return to support the country's economy. Diplomats have shown willingness to address the issue, with attention focused on former Land Minister







Saifuzzaman Chowdhury, whose property acquisitions in the UK have raised suspicions of illicit financial activity.

India

 David Wallace, Acting High Commissioner to Malaysia, and YB Datuk Seri Utama Tengku Zafrul Aziz, Malaysia's Minister of Investment, Trade, and Industry, jointly unveiled the countdown to the UK's entry into the CPTPP.

Japan
